This is an internal review of an officer involved use of deadly force. On January 29, 2010, officers responded to a 911 call for a welfare check on a female, her three small children, and her possibly suicidal boyfriend at 12800 NE Sandy Blvd. #37. The male, Aaron Campbell, eventually came out of

the apartment. A less lethal shotgun was deployed by Officer Lewton. Moments later, Officer Frashour fired his AR-15 rifle once, striking Campbell in the back. Campbell was pronounced dead at the scene.

2. Was the use of less lethal force by Officer Lewton within Bureau policy and training guidelines? (Force)
3. Was the response by PPB personnel tactically sound and within Bureau policy and training guidelines? (Procedure)
