911 OPERATOR: 911.

STEWART: Yes, I need for the police to go out and do a welfare check on my niece. Her boyfriend is real suicidal. He done already tried to kill hisself...

911 OPERATOR: Okay.

STEWART: ...and now we can't get no contact from her.

911 OPERATOR: Okay.

STEWART: And he has a gun.

911 OPERATOR: Mam, mam, what's the address please?

STEWART: Uh, she lives, I don't know the exact address. It's 125th & Sandy. It's the Sandy Terrace Apartment.

911 OPERATOR: The Sandy Terrace?

STEWART: Yes.

911 OPERATOR: And what apartment number?

STEWART: 37.

911 OPERATOR: Number 37.

STEWART: Yes.

911 OPERATOR: Okay, that's about 128th & Sandy, right?

STEWART: Right somewhere in there.

911 OPERATOR: Okay.

STEWART: Yeah, because,

911 OPERATOR: What's your name, please?

STEWART: My name is SHERRY.

911 OPERATOR: What's your last name SHERRY?

STEWART: STEWART.

911 OPERATOR: STEWART?

STEWART: Yeah, and her name is ANGIE JONES.

911 OPERATOR: Okay, and we're going to be checking on, her name again is?

STEWART: ANGIE and can I also tell you just proceed with caution because he already wants the police to kill him. His brother just died this morning and so that's where his mind is. He wants the police to kill...

911 OPERATOR: Okay, but I'm gonna...what is ANGIE's last name?

STEWART: JONES.

911 OPERATOR: JONES?

STEWART: Uh-huh.

STEWART: ANGIE is 23.

65 He left. Why she let him back in I don't know, but ever since she let him back
66 in nobody has heard from her. Her mom.....
67 911 OPERATOR: How long has it been since you've heard from her?
68 STEWART: Uh, it's been over an hour now.
69 911 OPERATOR: What is her phone number?
70 STEWART: Her phone, let me look, I got to look on my phone to get her number.
71 911 OPERATOR: That's okay, all right, go ahead.
72 STEWART: Okay. Okay, it's 503-367-0365.
73 911 OPERATOR: So, that was about an hour ago he did this?
74 STEWART: Yes, this has been going on all this morning, we just found out.
75 911 OPERATOR: Okay, with, with the gun incident you just told me, was that about an hour ago?
76 STEWART: Yes.
77 911 OPERATOR: Okay.
78 STEWART: And nobody has had contact with her since.
79 911 OPERATOR: Okay, now I'm getting the police started while we're talking. Do you say he
80 wants, um, he wants to possibly do suicide by police?
81 STEWART: Yup.
82 911 OPERATOR: Okay, what is his name?
83 STEWART: AARON CAMPBELL.
84 911 OPERATOR: Do you know his date of birth or how old he is?
85 STEWART: Uh, AARON is probably, I don't know 25, 26.

94 he used to have like maybe shoulder-length hair. I don't know if it's still
95 braided or if he still has that much hair or not.
96 **911 OPERATOR:** Do you know what kind of weapon he was armed with?
97 **STEWART:** Uh, no. She didn't even say.
98 **911 OPERATOR:** Okay, this information came from your daughter, is that correct? I mean your
99 niece is it?
100 **STEWART:** Yes. Because when he came back when I was talking to her she immediately got
101 off the phone and texted me with like he's back I got to call you later and I
102 haven't heard from her since.
103 **911 OPERATOR:** Okay, all right. Does he drive a vehicle?
104 **STEWART:** Yes, but I don't know what kind of car he has.
105 **911 OPERATOR:** So, he had a brother that died this morning?
106 **STEWART:** Yes.
107 **911 OPERATOR:** And you got all this information from your niece?
108 **STEWART:** Yeah, well we knew about the brother was about pass because he had heart
109 problems so he had...the information I'm giving you about the gun, the
110 suicide...
111 **911 OPERATOR:** Yes.
112 **STEWART:** ...that all came from her.
113 **911 OPERATOR:** In a text?
114 **STEWART:** No, we was talking on the phone. He wasn't there when I first talked to her,
115 but then when he came back she hung up on me and then texted me and said
116 that he was back and that she couldn't talk to me. She had to call me back
117 later. Well I sat here and thought about it for a minute and I'm like no that's
118 not okay and so I've been calling her ever since then and...

120 **STEWART:** ...she won't answer. I texted, like I'm going to send the police if you don't call
121 me and she still hasn't.
122 **911 OPERATOR:** Okay, all right. We've got police on the way...
123 **STEWART:** Okay.
124 **911 OPERATOR:** ...and we should be there shortly, okay?
125 **STEWART:** All right, thank you.
